Pursuant to the decision of the High Power Committee taken in its meeting held on dtd. 25.08.2021 read with approval of Govt. vide **Letter No. 10287/SME, Dated 25-08-2021** and as per the guidelines issued by the Government in the Department of School & Mass Education, odisha, Bhubaneswar vide Resolution No. 30720/SME dtd.23.09.96 read with G.O. No. 29519/SME dtd. 26.9.1998 Provisional **No Objection Certificate (NOC)** is hereby granted in favour of **SRI SATHYA SAI ANANDAM SCHOOL, DARUTHENGA, KHURDHA**, for a period of **One Year** to upgrade/ run Self Financed High School with Class-IX & X which is to be affiliated to **CBSE** subject to following terms & conditions. The extension of NOC beyond **One Year** will be considered after ensuring fulfillment of the terms & conditions.

1. The No Objection Certificate now issued shall be subject to the terms & conditions as prescribed in G.O. No. 30720/SME dtd. 23.09.96 and No. 29519/SME dtd. 26.09.1998 read with G.O. No. 10011/SME dtd. 11.06.2004. Any relaxation extended this year shall be fulfilled within one year.
2. The School shall be open to inspection by the Officers of S & ME Deptt. As and when required.
3. No Financial Assistance of any kind of Grant-in-Aid (either recurring & non-recurring) will be claimed by the institution from the Government at any point of time.
4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same in any violation of terms & conditions laid down in Govt. Acts/ Rules/ Executive Instructions is notified in future.
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.






