- 4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same in any violation of terms & conditions laid down in Govt. Acts/ Rules/ Executive Instructions is notified in future.
- 5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
- 6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
