PROCEEDINGS OF THE HIGH POWER COMMITTEE MEETING HELD ON 11.01.2023 AT 11.00 A.M. IN THE CONFERENCE HALL OF COMMISSIONER -CUM- SECRETARY, S&ME DEPARTMENT FOR GRANT/ WITHDRAWAL OF PERMISSION/RECOGNITION TO PRIVATE HIGH SCHOOLS/SANSKRIT TOLS.

A meeting of the High Power Committee (HPC) was held under the Chairmanship of the Commissioner- cum -Secretary to Govt., S&ME Deptt. to deliberate and decide on the different agenda items pertaining to grant of permission/recognition/NOC to private High Schools (both English & Odia medium) and also Sanskrit Tols . The list of members present in the meeting is at **Annexure-I**.

I. HIGHER SECONDARY SCHOOLS

The Special Secretary, Higher Secondary Education, School & Mass Education Department presented one case before the Committee for grant of NOC for Class XI&XII.

- (i) Koustav International School, Patia, Bhubaneswar- After a detailed discussion, it was decided not to grant NOC for opening of Class XI&XII to the school. It was also decided to call for a report from DHSE(O) regarding continuance of Classes 1 to 10 in the school.

II. HIGH SCHOOLS

Director, Secondary Education, Odisha placed the following matters for discussion and consideration of the Committee.

1. Odia Medium High Schools:

a. Post Facto Approval:

The Director, Secondary Education, Odisha informed the committee that though the last meeting of the HPC was held on 20-04-2022, the decisions taken therein were not finalized. During the intervening period after 20-04-2022, the then Director had issued permission/recognition to following 13 High Schools (except Sl. No.-2) to meet court dateline and to enable the students of those schools to appear in Board examinations.

The list of such schools was placed before the present Committee for post facto approval. The Committee desired to examine the eligibility of such schools first. After necessary scrutiny and basing on the recommendation of the DSE (O), the Committee

Accordingly, the DSE was requested to separately communicate the orders of the HPC to the petitioner and to give a hearing to him in case he is aggrieved by the said order and files a review petition to that effect as per Sec 6(10) of the OE Act 1969. If his findings are different from the findings in DEO report, he will revert back to HPC. Otherwise necessary speaking order shall be passed by him separately towards compliance of Court direction.

2. English Medium High Schools:

a. Post Facto Approval:

The DSE(O) informed the Committee that, the DSE had issued NOC to the following 32 English Medium High Schools to meet CBSE/ICSE affiliation datelines. Out of above 32 cases, in first 11 cases written approval of the then Principal Secretary was taken on 21-05-2022 in OSWAS file No. DSEO-FEV-NOC-0001-2022.

The DSE placed the matter before the present Committee for ex-post facto approval. The Committee wanted to examine the eligibility of each school first. After detailed discussion, the Committee agreed to accord post facto approval to the following 32 schools with the condition that it will not be cited as a precedent in the future.

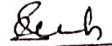

Pursuant to the Whatsapp message of **Principal Secretary to Govt. Department of School & Mass Education, Odisha** and as per the guidelines issued by Government in the Department of School & Mass Education, Odisha, Bhubaneswar vide Resolution No. 30720/SME dtd.23.09.96 read with G.O No. 29519/SME dtd. 26.9.1998 **No Objection Certificate (NOC)** is hereby granted in favour of **Sri Sathya Sai Anandam School, Daruthenga, Chandaka, Bhubaneswar, Khordha** for a period of **One Year** to run Self Financed High School with class- IX & X which is to be affiliated to **CBSE** subject to post facto approval of HPC. The extension of NOC beyond **One Year** will be considered after ensuring fulfillment of the terms and conditions.

1. The No Objection Certificate now issued shall be subject to the terms & conditions as prescribed in G.O No. 30720/SME dtd.23.09.96 and No. 29519/SME dtd. 26.09.1998 read with G.O No. 10011/SME dtd.11.06.2004. Any relaxation extended this year shall be fulfilled within one year.
2. The school shall be open to inspection by the Officers of S & ME Deptt. as and when required.
3. No Financial Assistance or any kind of Grant-in-Aid (either recurring & non- recurring) will be claimed by the institution from the Government at any point of time .
4. The High Power Committee shall be competent to review the NOC now granted to the institution concerned and shall be competent to withdraw the same if any violation of terms and conditions laid down in Govt. Acts / Rules / Executive Instructions is noticed in future.
5. The Managing Committee shall be constituted in accordance with the Sec-7 of the Odisha Education Act-1969 as amended from time to time.
6. The school shall not be shifted from its present location without prior approval of Director, Secondary Education, Odisha.
7. At present the school land is not in the name of the School. It will be the responsibility of the management to record the required land (1.00 Ac.) in School name and copy of RoR submitted within one year to the Directorate for continuance of NOC.
